MODERNIZING OUR MESSAGE Your support is needed to update our site

t has served us well over the years but the **Cincinnatus** website needs an overhaul.

A lot has changed in web infrastructure and design since our site launched during Internet's Stone Age (2005). As **President Mark Silbersack** explains it: "Our website is technologically obsolete. and is far less attractive and useful than it should be for members and the general public.

Funding the New Site

OUR HOST TONIGHT BROMWELL'S A QUEEN CITY GEM

Many thanks to our host and Cincinnatus member, JEFF McCLOREY, who bought Bromwell's in 2005. Here's a little history, compliments of the company website:

"Bromwell's has been in continual operation since 1819. It has always been family-owned and managed remarkably, by only three families over the course of its 185-year history.

"The Bromwell family can be traced back nearly 400 years, to the beginning of U.S. history, starting with Isaac Bromwell. He was master of the ship Assurance that brought in 220 colonists from England to Virginia in 1635.

"In the late 1700s, descendants hailing from Baltimore learned the trades of wire-goods making and lumber from England. One family member, Jacob Bromwell (1785-1866), settled in Cincinnati to start the Bromwell wire weaving business in 1819.

"Cincinnati quickly arew and became a gateway to Westward expansion. Bromwell's grew with it, supplying pioneering families a multitude of household goods."

We visited the E.W. Scripps Co. for a tutorial in web design. What we learned is that today's designs stress simplicity. Often, the best home page is simply a visually appealing, easy-tonavigate index of the deeper content. That's the design we'll commission.

After taking bids and talking to vendors, we have found a good team for our redesign. Cincinnati freelance designer Ryan Ostrander will provide our site's look, and Signal Networking, Inc., of Alexandria, KY, will build the infrastructure and host our site. Both have worked with us on price and proven themselves flexible in building the site as we move forward.
